

Quotations are invited by the Maharashtra Labour Welfare Board for the above work as per following conditions given below :-

1. The Quotations Should be Furnished in a sealed Envelope at the above address up to 03.00 P.M. on 11.06.2021. Name of the specific work mentioned clearly on the Envelope and Envelope will be opened on the same day if possible in the presence of the Bidders.
2. The bidders shall quote the rate in percentage above/below/at par of the estimated cost of work and Quotation amount should be in words and in figures as well.
3. Earnest Money : Rs.10000/-
4. The estimated cost of the work is Rs.9,44,123.66/- Only All inclusive.
5. Contractor should furnished all valid registrations as follows:-
 - A) PWD Registration Certificate
 - B) GST Certificate
 - C) PAN Card
 - D) EPF Certificate
6. The rates shall be quoted inclusive of all taxes and delivery at the site.
7. The Quotations submitted by the Intending Bidders will be binding on him for the period of three months from the last date of receipt of Quotations.
8. The Work Should be completed within 30 days after the date of work Order.

9. The details of the materials / work are enclosed herewith.
10. The contractor will have to make his own arrangement for office, stores and safeguard for the materials brought by him on the Work Site and the materials issued by the department if any.
11. The contractor will have to provide labour and tools required for lining and setting out the layout etc. for the work without any payment.
12. The Bidders may inspect the site work before quoting the rate and acquaint himself with the site conditions.
13. The work shall be carried out accordance with I. S. specifications to the particular item and as per the detailed specifications mentioned/attached herewith.
14. No alterations in the form of Quotations or schedule of quantities, specifications and in the shape of specials stipulated will be submitted.
15. The contractor has to repair to the damage occurred if any during the course of work free of cost.
16. The contractor should have to take pictures of above mentioned work.
(Before starting work, during the course of work and after completion of work.)
17. Five Percent (5 %) of the fee payable to the contractor shall be retained from bill as "Retention Money", in addition to the performance guarantee. The retention money will be discharged by the MLWB and returned to the contractor after successful completion of the Work at site and submission of completion of defects liability period. the rights forfeiture of the Retention Money in additions to other claims and penalties in the event of the consultant's failure to fulfill any of the contractual obligations.
18. After completion of the work, the contractor shall remove forthwith all his serviceable and un-serviceable material from site of work and other debris shall be dumped and leveled if any as ordered within site of work if so ordered without any extra cost.
19. Contractor should comply all the rules & regulations of PWD Maharashtra for the above mentioned work.
20. After completion of work contractor should produce the bill as per actual work completed on site. Bill shall be paid as per the actual measurements / quantities.
21. Contractor should follow all the instruction given by MLWB at time to time.

22. Welfare Commissioner have the Rights to Accept or Reject Any Quotation without Giving Any Reason.
